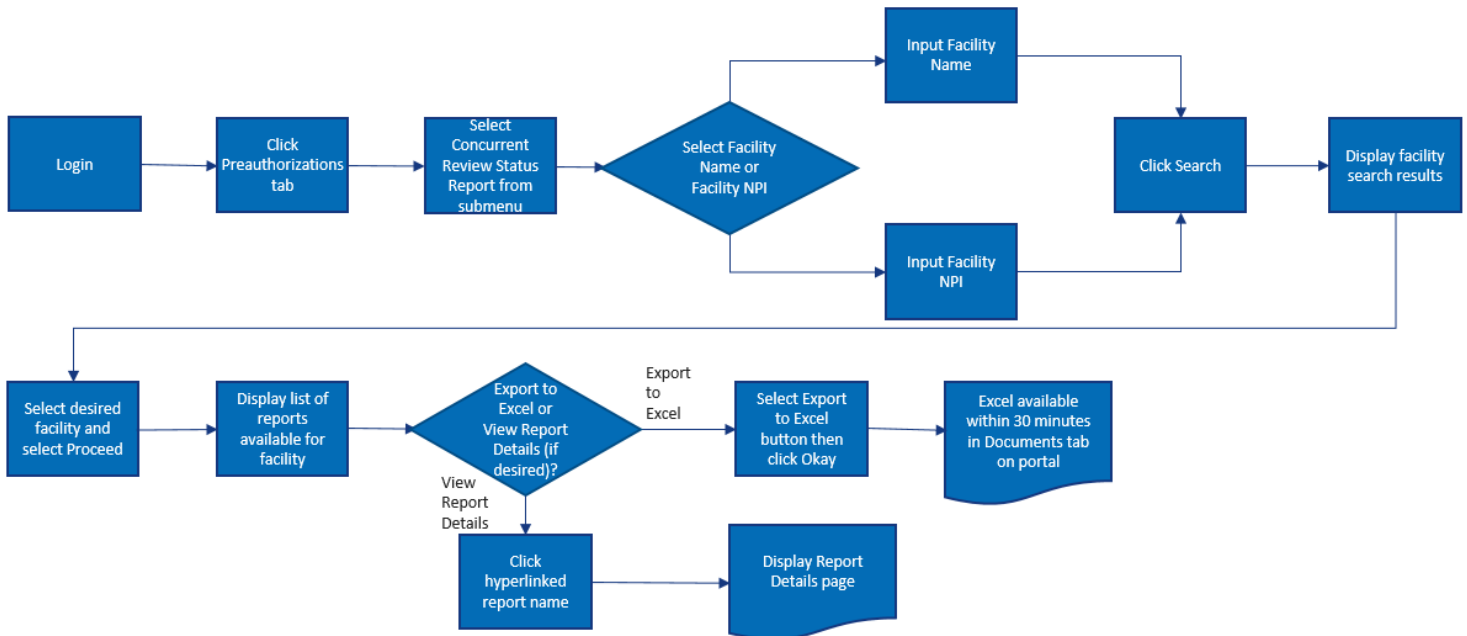


Preauthorization Concurrent Review Status Report

Quick Reference Guide (QRG)



This Quick Reference Guide (ORG) will provide an overview of the Concurrent Review Status Report process on the Provider Portal.



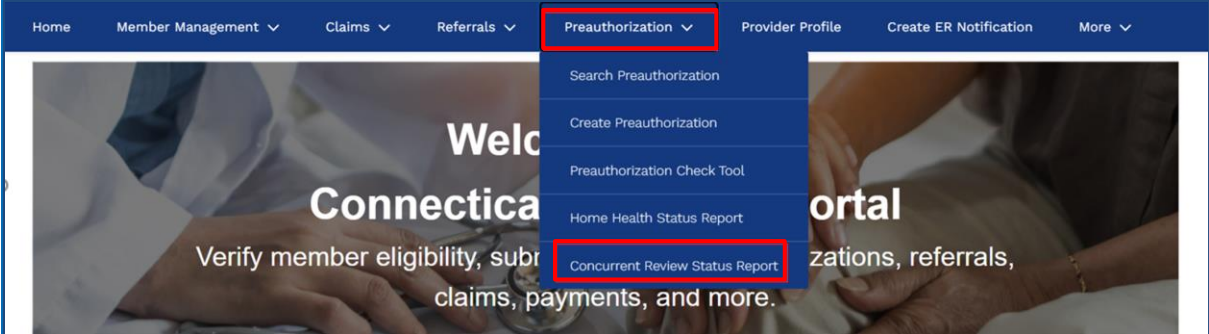
Let us look at the steps in detail for the Concurrent Review Status Report process.

Purpose: To view the Concurrent Review Status Report.



Step 1:

- To search for a Concurrent Review Status Report from the Provider portal home screen:
 - From the menu, select the **Preauthorization** tab.
 - From the drop-down list, select **Concurrent Review Status Report**.





Step 2:

1. In the **Search By** field, select Facility Name or Facility NPI from the drop-down menu.

Note: For this example, we will use **Facility Name**.

Step 3:

1. Enter the **Facility Name** in the field.

Note: The fields **Specialty**, **City**, **State**, and **Zip Code** are optional. You can enter the details in these fields if you want more precise search results. In the **Facility Name** field, you can search by entering at least 2 characters of the **Facility Name**. In the **Specialty** field, you can do a partial search by entering 4 letters.

2. Click **Search**.

Step 4:

1. The Facility details display, including the **Address** and **NPI number**.
Note: Alert message will appear if search criteria did not return any results. You can use **Filter By** to filter the required Facility details from the search results.
2. Select the required row from the search results.
3. Click **Proceed**.
